LIFE IN TALEGA

Talega is a twenty-year new Master Planned Community that is situated on 1,500 acres in the hills above San Clemente.

The community consist of a blend of single-family detached homes with a balance of condominiums and some apartments with a totaling some of 3,864 doors.

Location:

Talega is located in the hills above San Clemente, the "Spanish Village by the Sea", on the Southern California Coast, midway between Orange County and San Diego. San Clemente features world renowned beaches and surf breaks (Trestles, T-Street, Califia, Onofre, Trails, etc.) with a great variety of waves. Its Spanish colonial style downtown area has plenty of shops and restaurants adorned with red tile roofs, cream stucco walls, and dark wood doors and windows. San Clemente is surrounded by beautiful mountains and open spaces, including the The Reserve at Rancho Mission Viejo, Cleveland National Forest, and Marine Corps Base Camp Pendleton.

San Clemente has a very pleasant climate with 281 sunny days per year, only 13 inches of rain – the US average 39 inches -, and temperatures from mid-forties in the Winter to nineties in the Summer.

Talega is only four miles away from the closest beach (North Beach).

Talega Amenities:

Talega offers many resort-style amenities. There are 2 lap pools (heated year-round), 2 recreation pools (seasonal), 19 miles of hiking trails, programs, clubs, special events, a sports court, a sand volleyball court, tot lots and so much more!

Pools - The Talega Swim and Athletic Club has a recreation pool, a 25-yard lap pool and a Splash and Play Fountain. Talega also has a 25-yard lap pool at Saluda and a recreation pool at Tierra Grande. Both lap pools are heated year-round. Recreational pools are seasonal (open April-October). Please visit www.talega.today/facility-information for pool rules.

<u>Sport Courts</u> - Talega's Clubhouse features a mixed-use tennis and basketball court as well as a sand volleyball court next to the resort pool area. Please visit <u>www.talega.today/facility-information</u> for Sports Court rules.

<u>Facilities</u> - Talega's Clubhouse features a large Club Room and a smaller Terrace Room, both of which are available to homeowners to rent for private functions. The Clubhouse also features a sitting room with a fireplace, a TV room, and a catering kitchen facility. By calling the clubhouse, you may reserve the fireplace room and TV room during the day for small meetings. The Terrace Room has a 32-person occupancy. Typically, this room holds most of Talega's daytime programs. This room is also available to rent for non-profit meetings and parties to Talega homeowners.

The <u>Bella Collina Towne & Golf Club</u> has been designed with three integrated nine-hole layouts, which may be linked to provide an endless variety even for the most demanding golfer. The <u>Gary Player</u> signature course was designed in the tradition of Scottish seaside links, the 27 championship holes wind gently through ravines, lakes and natural foliage, while preserving the rugged environment and special character of the land.

The Nature Reserve at Rancho Mission Viejo - The Reserve at Rancho Mission Viejo is a non-profit organization whose mission is to preserve and enhance Reserve lands for ecological, educational, charitable, conservation, open space, scientific and recreational issues. TSAC Access Fobs & Gate Transponders:

New and Replacement Key Fobs are issued at the Talega Swim & Athletic Club located at 100 Calle Altea San Clemente CA 92673, Monday – Friday from 9:00am to 4:30pm. The office is closed from 12:00pm - 1:00pm for lunch on weekends.

New Homeowners - To obtain a pool access FOB(s) or vehicle gate equipment, please bring your photo I.D. and settlement statement (hud-1) or recorded grant deed to the T.S.A.C. Clubhouse. If the previous homeowner left keys or gate equipment for you, please bring those with you to the office. Residents may find the "Non-Gated Community Member Registration Form" and the "Gated Communities Registration Form" in the <u>Homeowner Portal</u> or get them from the TSAC office.

Residents Renting a Home - To obtain a pool access FOB(s) or vehicle gate equipment, the homeowner on the title must first fill out the Rental Membership Registration form and have indicated that there will be renters in the property. The form has 2 sections that need to be completed. The form can be obtained at the Talega Swim & Athletic Club.

Section 1: Top portion is only for the registered recorded homeowner/landlord to complete with their information. We will accept an e-mailed copy, but it MUST be legible and accompanied by a copy of the photo ID for the homeowner/landlord. If there is a property management company involved, please contact the office for additional instructions at (949) 361-8466.

Section 2: Tenant portion of the form to be completed only after the first section has been completed by the homeowner/landlord. This section to be completed in the presence of a TMC staff member and a photo ID will be verified.

If the homeowner/landlord has any transponders, and key fobs, etc. they are to bring those in with them or have the tenants bring them into the office along with the completed form, and a fully executed current lease agreement. If we already show the max amount of access cards issued to the homeowner and they are lost, payment to replace them is required by check and/or credit card for \$25 each. No refunds.

Residents may find the "Rental Property Membership Form" in Talega's Homeowner Portal or the TSAC office.

Pinnacle or Mendocino Renters -To obtain a pool access FOB(s), please bring a photo I.D. and a copy of your fully executed current lease agreement reflecting the start and termination date of your lease.

SUB-ASSOCIATIONS & PROPERTY MANAGEMENT COMPANIES

Talega HOA is a Master Planned Community with single-family homes, townhomes, condominiums, and apartments. Most Sub-Associations are not managed by FirstService Residential. Although, Sub-Associations also belong to the Talega Maintenance Corporation (TMC). Homeowner's who live in a Sub-Association pay HOA dues to their Sub-Association and in addition to, the Master Association (TMC).

TMC & TLC HOA DUES AND FEES

When purchasing a home in Talega there are two (sometimes three, if you live in a <u>Sub-Association</u>) Associations that require a payment: Talega Maintenance Corporation and Talega Lifestyle Corporation. These corporations are two separate entities with two separate funding sources and Boards of Directors. However, they work together to maintain Talega as great place to live.

Talega Maintenance Corporation:

TMC is the master association. When you purchase your home in Talega, you automatically become a member of the TMC. Your membership allows you to enjoy all of the amenities Talega has to offer such as; 4 Pools, a Splash Pad, Lighted Sand Volleyball Court, Lighted Tennis and Basketball Court, Clubhouse, Meeting Rooms, 15 Miles of Trails and 7 Tot Lots. TMC is organized as a non-profit corporation run by all-volunteer Board of Directors who accomplish the operations and maintenance of the community through management and staff with valuable input and hard work from various volunteer committees.

The day-to-day operations, maintenance and the reserve placement fund that ensure your continued enjoyment of the foregoing are provided by the monthly HOA assessments/dues which are currently \$224 per month. Assessments are due on the first of each month. Additional fees apply if you live in a gated neighborhood or in a sub-association.

The first month of HOA dues are typically included in the close of escrow. Once the escrow company sends in the closing paperwork to FirstService Residential, your name will appear on your account and a statement will send to the billing address that they had on the paperwork. This could take up to four weeks.

Talega Lifestyle Corporation:

TLC is an organization that was established by the master developer in the early planning stages of the project to foster a sense of community within Talega. Its purpose is to promote the common good and general welfare of the people of Talega through civic betterments and social improvements. The TLC accomplishes this through the promotion and implementation of social opportunities, community programs, recreation and technology. Typically, there are 18-22 events that take place each year.

The TLC has a Community Events Manager that coordinates all events and programming. This position is funded through the TLC budget. The Talega Lifestyle Corporation is governed by a Board of Directors who meet on a routine basis to make the business decisions of the TLC. The TLC always welcomes feedback and suggestions on existing events and event suggestions. Community volunteerism is the engine of the TLC and will determine the future of the organization. The TLC is funded by "Lifestyle Fees" that are generated and collected through escrow each time a home sells in Talega. The amount is calculated as ¼ of 1% of the sale price and is used solely to support and sponsor the social programming aspect of Talega.

REAL ESTATE SIGNAGE RULES

- 1. No sign, poster, billboard, advertising device, or other display of any kind shall be displayed for public view except such signs as may be used by Declarant and Participating Builders, Apartment Project Owners, and their successors, in connection with the development of the Property and the sale or leasing of apartments or residences. All signs must conform to all applicable governmental ordinances.
- 2. The following criteria applies to "FOR SALE/LEASE" signs:
 - All signs for the purpose of selling a Residence must be professionally prepared on weather-resistant material and shall not exceed 24" X 36".
 - The number of signs on any Lot shall not exceed one (1) sign.
 - No signs shall be placed on TMC Property, which includes, and may not be limited to, landscaping, median islands, poles, and buildings.
 - An Owner may display on his/her Lot or on real property owned by others with their consent, signs of
 reasonable dimensions and design, which are reasonably located, and which advertise the property for sale
 or lease.
 - The top of the sign shall not exceed 3'-0" above ground level.
 - No sign shall be attached to the ground by means other than a conventional single vertical stake which shall not exceed 4" X 4" in diameter.

Items #3 – 10 below apply specifically to Open House signage on TMC property:

- 3. Owners (or their agents) wishing to advertise an "OPEN HOUSE" for the purpose of directing traffic to their Residence for sale, must use the approved TALEGA OPEN HOUSE directional sign.
- The TALEGA OPEN HOUSE directional sign may only be purchased through the approved vendor: Real Estate Signs & Supplies (R.E.S.S)

- 5. Owners (or their agents) wishing to purchase a TALEGA OPEN HOUSE directional sign may request a sign order form from R.E.S.S., from the Talega Swim & Athletic Club.
- 6. Only one Talega OPEN HOUSE directional sign, pointing in any one direction, per street corner will be allowed. (i.e. if there is more than one open house heading in the same direction, there will still be only one Talega OPEN HOUSE sign used as a directional to the Open Houses.)

- 7. Owners (or their agents) wishing to advertise "OPEN HOUSE" at the property address for the purpose of selling their Residences, must use a standard sign to conform as follows:
 - No larger than 10" x 30",
 - Professionally prepared
 - Includes the words "OPEN HOUSE."
- 8. Signs may not remain on TMC Property overnight.
- 9. No riders or flags are permitted.
- 10. Signs not complying with the community Guidelines will be summarily removed by TMC.
- 11. Display of Signs, Posters, Flags and Banners (Civil Code 1353.6):
 - Noncommercial signs, posters, flags, or banners may be posted or displayed on or in an owner's separate
 interest, except as required for the protection of public health or safety or if the posting or display would
 violate a local, state, or federal law.
 - Noncommercial sign, poster, flag, or banner may be made of paper, cardboard, cloth, plastic, or fabric, and may be posted or displayed from the yard, window, door, balcony, or outside wall of the separate interest.
 They may not be made of lights, roofing, siding, paving materials, flora, or balloons, or any other similar building, landscaping, or decorative component, or include the painting of architectural surfaces.
 - The association prohibits non-commercial signs and posters that are more than nine (9) square feet in size and non-commercial flags or banners that are more than fifteen (15) square feet in size.
 - Flags, signs and posters that fall into disrepair or become unsightly must be removed or replaced.
